The following is Management's Discussion and Analysis ("MD&A") of the financial results of operations of Strategem Capital Corporation ("Strategem" or the "Company") for the three and nine months ended September 30, 2025, which have been prepared in accordance with International Financial Reporting Standards ("IFRS"), including International Accounting Standard ("IAS") 34, Interim Financial Reporting. This discussion should be read in conjunction with the financial statements and the notes thereto for the same period as noted above (collectively, the "Financial Statements"). DESCRIPTION OF THE BUSINESS

Strategem is a publicly - listed company with an objective for continued growth through investments in resource exploration and development, mining, and energy production and agricultural protein products. The Company's Class A shares trade under the symbol "SGE" on the TSX Venture Exchange (the "TSX-v" or the "Exchange").

The Company is classified as a "venture issuer" for the purpose of National Instrument 51-102. Unless otherwise cited, references to dollar amounts are expressed in Canadian dollars. Throughout this report we refer from time to time to "Strategem", the "Company", "we", "us", "our", or "its". All these terms are used in respect of Strategem Capital Corporation, which is the reporting issuer in this document.

OVERVIEW

During the three months ended March 31, 2026, the Company invested in short term securities and recognized net unrealized gains of \$1,250 (2025 – unrealized loss of \$677). The Company continues to look for investments with the potential for growth and where it could be actively involved in management or have a position of control.

Subsequent to the quarter end, the Company regained compliance with the minimum distribution requirement of the TSX Venture Exchange, having previously disclosed its non-compliance on October 28, 2025. The Company now meets the Exchange's minimum number of public shareholders holding board lots, thereby remedying the prior deficiency. This subsequent event does not result in any adjustments to the financial statements as at March 31, 2026.

DISCUSSION OF OPERATIONS AND FINANCIAL CONDITION

The Company's earnings and losses are expected to fluctuate significantly and will depend on its ability to identify and acquire investments that will appreciate in value (see "Description of the Business", above), and the exchange rate fluctuations.

Three months ended March 31, 2026 compared to Three months ended March 31, 2025

During the three months ended March 31, 2026, the Company recorded total revenues of \$1,302 consisting of interest, dividends and other income of \$58 and unrealized gain on investment of \$1,250, offset by net loss on sale of investments of \$3.

During the three months ended March 31, 2025, the Company recorded total losses of \$590 consisting of unrealized losses on investment of \$677 offset by interest, dividends and other income of \$59 and net gain on sale of investments of \$28.

For the three months ended March 31, 2026, expenses were \$126 compared to \$75 for the three months ended March 31, 2025. The variances in expenses over the periods are due to the timing of directors' fees.

For the three months ended March 31, 2026, net income was \$1,184 or earnings per share of \$0.13, compared to net loss of \$665 or loss per share of \$0.07 for the three months ended March 31, 2025.

LIQUIDITY AND CAPITAL RESOURCES

As at March 31, 2026, the Company had total assets of \$12,083 and working capital of \$12,046 as compared with total assets of \$10,916 and working capital of \$10,862 at December 31, 2025. The Company's cash position (cash and cash equivalents) as at March 31, 2026 was \$307 compared to cash and cash equivalents of \$918 at December 31, 2025.

The Company has adequate working capital to fund its expected operating costs through 2026.
